ACCESS for English Language Learners (ELL) 2.0 Online Assessment Training II

The Assessment Section, in the Office of Strategy, Innovation and Performance, in collaboration with the ELL Program, in the Office of Curriculum, Instruction and Student Support, will provide additional ACCESS for ELLs 2.0 Online training for test coordinators and ELL coordinators in December 2017.

This one-day training is an extension of the training held in September and is intended for ACCESS Online Program ELL coordinators and school test coordinators on a space available basis.

WHO should attend the December 2017 training sessions?

- Test coordinators and ELL coordinators who need additional support in test coordination and administration of the ACCESS Online assessment.
- School Assessment Team members who assist in the coordination and administration of the ACCESS Online assessment.

Separate technology coordinator webinars will be provided which will cover technology requirements and procedures to set up the online delivery system. Technology coordinators need not attend the ACCESS Online Training II unless also planning to coordinate and administer the ACCESS online assessments.

WHAT should I bring to the training session?

• Each participant is expected to bring a laptop to the training session.

WHAT topics will be covered at the training sessions?

 Test coordination; test administration procedures including hands-on practice setting up a test session, starting a test session and completing a test session; administering practice tests using the secure browser; accessibility and accommodations; technology requirements; test security and ethics; accessing results using the WIDA-AMS system.

WHEN and WHERE will the training sessions be held?

- Participants are to attend the scheduled training in their school's district.
- There will be a one-hour lunch break.
- Sign-in begins at 8:00 a.m.
- Training sessions begin promptly at 8:30 a.m. and end at 3:00 p.m.
