**General Information**

**1. Cancellation of ALL Statewide Summative Assessments for SY 2019-2020**

All federally-mandated assessments are officially canceled for the remainder of this school year. These assessments include the Smarter Balanced Assessments in English Language Arts/Literacy and Mathematics, the Hawaii State Science Assessments (NGSS) Grades 5 and 8, the Biology 1 End-of-Course Exam, the Hawaii State Alternate Assessments, and the Kaiapuni Assessment of Educational Outcomes (KĀ‘EO). The U.S. Department of Education has approved the Hawaii Department of Education’s request for a waiver for flexibility regarding assessments, accountability and school identification, and reporting requirements pursuant to section 8401(b) of the Elementary and Secondary Act of 1965, as amended. The Hawaii Board of Education members approved the HIDOE to proceed with the waiver.

**2. ACT, SAT, and AP Scam Calls**

It has come to the attention of the Assessment Section that parents of students are receiving calls from a person claiming to be part of the ACT and College Board, requesting that parents make a deposit so that students may participate in online testing in their homes.

We have confirmed with the ACT and College Board that this is a scam call, and they have alerted their Customer Service staff so that they may assist concerned parents and schools. ### 3. Spring 2020 ACT Makeup Test Options

A memo has been posted titled “Spring 2020 ACT Makeup Test Options” dated April 20, 2020, that addresses the cancellation of the spring ACT make-up dates. Schools will have options for the make-up that includes vouchers, or selecting alternate make-up test dates of September 22, October 6, and/or October 20, 2020 to administer the test.
