### General Information

#### 1. Annual Hawaii State Assessment Program Training Conference - Virtual

Principals, Complex Area Staff, Test Coordinators, Student Service Coordinators, Test Accommodations Coordinators, and HSA-Alt Test Administrators are invited to attend the virtual 2021-22 Hawaii State Assessment Program Training Conference on September 13 and 14, 2021.

There will be over 26 sessions, including a keynote and plenary presentations, covering a wide variety of topics helpful to test coordinators, DATA team members, Student Services Coordinators, and school administrators. Time will be provided at the end of each day for attendees to take part in Q&A sessions with the various presenters. A memorandum with more information including a registration link and an agenda is forthcoming. Sessions will be recorded for those who are unable to attend, or have overlapping sessions they are interested in attending. School teams may wish to meet and discuss the agenda so they can plan to attend sessions accordingly.

#### 3. Assistive Technology Manual and Braille Resources 2021-2022

### 5. HSA-Alt Interim for Students in Grades 5 and 6 Available in November

An HSA-Alt Interim is under development and will be ready for students in grades 5 and 6 this November. Information on the Interim can be found in the [HSA-Alt Test Administration Manual](#). Teachers in grades 5 and 6 who would like to use this interim assessment with their students will be provided test administrator training during the Fall Intersession. The tentative hold date for this optional training for elementary school test administrators is Tuesday, October 12, 2021. ### 6. Test Accessibility and Accommodations Availability

ACT's [Test Accessibility and Accommodations](#) (TAA) system, which will be used to request accommodations and supports for the spring 2022 administration of the ACT, will open on September 13, 2021. ACT will host a training session for test coordinators and Test Accommodations Coordinators (TAC) on *Thursday, October 28, 2021 at 9:30 a.m. HST*. Test coordinators and Test Accommodations Coordinators can register for the webinar using this [link](#). Included in this webinar will be information about EL supports requests and any changes or updates to the request procedures. Staff who submit accommodations requests should confirm their access to the [TAA system](#) prior to the webinar.

### 7. MyACT PreTest Information

Prior to the spring 2022 administration of the ACT, students will once again complete the non-test (demographic and interest inventory) activity online via their MyACT account. ACT will distribute personalized non-test instructions approximately four weeks prior to Test Window One. The non-test instructions will be designed to help examinees establish their MyACT student account, and conduct the non-test activity prior to the designated deadline date. The state use questions have been discontinued as of last year. Test coordinators should expect that test times will be shortened by approximately 30-45 minutes by removing these tasks from the day of testing.
