### **Smarter Balanced**

#### 1. Remote Administration of the Smarter Balanced Interim Assessments Webinar

#### 2. Modified Process for Verifying Accommodations on State Assessments

For SY 2021-2022, there is a modified state test accommodation verification process and form for Test Coordinators (or authorized school staff member) to inform the Assessment Section about their students' use of prior verified test accommodations and/or their need for the verification of new ones. The modified process relies on school IEP/504 Plan Teams' expertise and their state test accommodation recommendations and is described in detail in the Hawaii State Test Accommodations Identification and Request Process for Test Coordinators and School Assessment Teams 2021-2022. Additional guidance can be found in Accessibility and Accommodations (A&A) resources that includes the Crosswalk of Accessibility Features Across State Assessments in Hawai'i (Crosswalk/CAF), the Smarter Balanced Usability, Accessibility and Accommodations Guide (UAAG), Hawai'i State Test Accommodation Guides, Guidance Brief on Math Manipulatives, and recorded Fall 2021 A&A training webinar and powerpoint.

#### 3. Smarter Balanced Accessibility and Accommodations Training Module

The <u>Smarter Balanced Accessibility and Accommodations Training Module</u>, which has been adapted for use by the Department, is designed to help school testing staff, IEP/504 Plan team members, and teachers to understand the designated supports and accommodations that are available for the online Smarter Balanced Assessments. Test coordinators are encouraged to share this training module with teachers and test administrators before test administration.

### 4. Aligning State Test Accommodation Records

Student Services Coordinators (SSCs) have received information on how to access school accommodation records in two locations: 1) the <u>electronic Comprehensive Student Support</u> <u>System</u> (eCSSS) and 2) the <u>Test Information Distribution Engine</u> (TIDE). At the next annual IEP/504 Plan team meeting, school IEP/504 Plan teams are to use the <u>Hawai'i State Test</u> <u>Accommodation Guides</u>, the <u>Guidance Brief on Math Manipulatives</u>, and the <u>Crosswalk of</u>

<u>Accessibility Features Across State Assessments in Hawai'i</u> (Crosswalk/CAF) as tools to make recommendations for state test accommodations and to update the eCSSS state test accommodation records. SSCs are to check the eCSSS record of IEP/504 Plan team accommodation recommendations for state testing against the records of prior verified accommodations in TIDE.

Note: Both the TIDE/eCSSS records currently show the state test accommodations that were verified for SY 2020-21. For SY 2021-22 state testing, Test Coordinators need to complete the <u>test accommodation verification request form</u> to inform the Assessment Section of the school IEP/504 Plan team's accommodation recommendations to retain and/or remove prior verified accommodations and/or to request the verification of new accommodations. Refer to the <u>Test Accommodations Identification and Verification Request Process</u> for further guidance.

### 5. Recording Designated Supports for IDEA, 504, and EL Students in eCSSS

IDEA, 504, and EL students who need designated supports for state testing must indicate those supports in eCSSS. For directions to record these supports in eCSSS, refer to the <u>eCSSS</u> <u>Directions</u>.

### 6. Checkpoint for Science Teachers

Checkpoint is a system that allows teachers to create items or access existing standards-aligned items to build and publish tests for their students. These tests can be administered to students using the Test Delivery System and the results are reported in the Centralized Reporting System. The Checkpoint system contains NGSS-aligned science items for grades 3 through 12 and the NGSS Interim Assessment items were recently added.

The <u>Checkpoint User Guide</u> can be found on alohahsap.org. There will be a one hour <u>Introduction to Checkpoint</u> webinar specifically for science teachers on Thursday, September 30, 2021 from 2:30 - 3:30.

### 7. HSA-Alt Interim Test Administrator Training on October 12

All HSA-Alt Test Administrators with alternate-identified students in grades 5 and 6 are encouraged to attend the HSA-Alt Interim Test Administrator Training on October 12. The virtual training will be held from 8:00 a.m. to 12:00 noon. Test Administrators who attend the training will receive a half-day stipend (or substitute coverage) and information about the new interim test. The window for submitting accommodations requests for the spring 2022 administration of the ACT opened on September 13, 2021 and will close on January 7, 2022. No new requests will be considered after January 7, 2022.

### 10. ACCESS for ELLs New Test Coordinator Training

The Assessment Section will conduct a WIDA ACCESS for English Language Learners (ELLs) assessments test coordinator training in October. This recommended training is for *new* WIDA ACCESS test coordinators *only*. (Another training will be held for all returning WIDA ACCESS test coordinators in December.)

Training sessions will be held October 5, 19, 21, and 26. *New* test coordinators may register for the training session in their district. The training sessions will be conducted via webinar (Webex) and will begin promptly at 9:00 a.m. and end at 2:30 p.m. Participants are expected to join the webinar from their usual work site unless otherwise directed by their principal/supervisor.
