1. Crosswalk of Accessibility Features Across State Assessments

This document has been updated for SY 2021-2022. The <u>Crosswalk of Accessibility Features Across State Assessments in Hawai'i</u> (Crosswalk or CAF) lays out the usability and accessibility tools for the following assessments: *Smarter Balanced (SB) ELA-CAT, SB ELA Performance Tasks, SB Math, HSA Science and Biology End-of-Course (EOC), and Algebra EOC exams.* This document, which was developed based on the <u>Smarter Balanced Usability, Accessibility, and Accommodations Guidelines</u> (UAAG), provides information about the universal tools, designated supports, and accommodations that are available by test content for state testing. 2. Hawai'i State Test Accommodation Guides, Guidance Brief, and Recorded Fall 2021 Accessibility and Accommodations Training

These resources are tools for school Individualized Education Program (IEP) and Section 504 Plan Teams to determine and support recommendations for appropriate accommodations that do not invalidate state test scores. The <u>state test accommodation guides</u>, the <u>Guidance Brief on Math Manipulatives</u>, and the recorded <u>Fall 2021 Accessibility and Accommodations training</u> are available on the <u>Accessibility and Accommodations Resources</u> page on <u>alohahsap.org</u>.

3. Assistive Technology Manual and Braille Resources 2021-2022

This <u>manual</u> provides an overview of the embedded and non-embedded assistive technology tools that can be used by students to access their tests in the Test Delivery System (TDS), including those students who require the Braille accommodation. It includes lists of supported devices and applications for each type of assistive technology that students may need, as well as setup instructions for the assistive technologies that require additional configuration to be compatible with the TDS. 5. SY 2021-2022 Online Statewide Test Accommodation Verification Request Form for Smarter Balanced Assessments

The online statewide test accommodation verification request form is available for school use on the Smarter Balanced (SB) ELA-CAT, SB ELA Performance Tasks (PT), SB Math, HSA Science and Biology End-of-Course (EOC), and Algebra EOC exams. SSCs, SPED DHs, test coordinators, and other authorized school staff should use this form to submit their school IEP/504 Plan Team's accommodation recommendations for state testing. Forms are to be submitted one month prior to the opening of the test window. (If circumstances require submission during a test window then the form must be submitted no later than 14 days prior to testing.) Refer to the request process document for more information about form submission deadlines. Schools will receive a response from the Assessment Section regarding a form submitted to remove prior verified test accommodations and/or to request the verification of new accommodations.
